SELLER also acknowledge that they have been informed that Virginia law requires that the seller notify the DMV after the sale of the vehicle. Your entire registration card should be mailed to DMV. Attention: Data Integrity. P.O. Box 27412, Richmond, Virginia 23269-0001, notify your local DMV or go to www.dmvnow.com if the SELLER does not notify the DMV of the sale of the vehicle and require proof of the sale after the fact, a document research fee of \$50.00 for the first fifteen minutes and \$75.00 per hour for any time there after will be charged to recover the SELLERS original sales documents. The SELLER warrants that the vehicle is being transferred free and clear of any liens and encumbrances. The vehicle is being transferred on an "AS IS" basis, with no warranties expressed or implied as to the condition of the vehicle. If this vehicle is considered an abandoned vehicle it must comply with 46.2-1200 Virginia code. If no title certification is available and a certificate becomes available it shall be delivered to DMV with a form provided by the commissioner, stating that the vehicle is demolished per 46.2-535 in the Virginia code. The undersigned SELLER certifies under penalty of law that the statements made in this Bill of Sale are true and correct to the best knowledge of the SELLER.
